महोदय,

कृपया इस कार्यालय के पत्र एफ0 संख्या 13–1/15(31)/11–12/टीएस/1205 दिनांक 12.01.2012 जिसके द्वारा नगरीय उपविधियां, नगरीय विरासत अधिनियम, स्थानीय विरासत राजपत्र, नगरीय विकास प्राधिकरण अधिनियम आदि की प्रतिलिपियां भेजने के लिए अनुरोध किया गया था एवं स्मरण पत्र एफ0 संख्या 13–1/15(31)/11–12/टीएस/1463–1479 दिनांक 14.03.2012 का संदर्भ ग्रहण करने का कष्ट करें।

02. आपको यह विदित है कि, प्राचीन स्मारक एवं पुरातात्त्विक स्थल तथा अवशेष अधिनियम 1958 (यथा संशोधित) के खण्ड 2 (i) एवं (j) के अनुसार, छत्तीसगढ़ राज्य में स्थित, भारतीय पुरातत्त्व सर्वेक्षण, रायपुर मंडल, रायपुर के अधीन सभी केन्द्रीय संरक्षित स्मारक/स्थल/अवशेष जिसकी सूची इस पत्र के साथ संलग्न है, केन्द्रीय सरकार के विभिन्न अधिसूचनाओं जिसका विवरण संलग्न सूची में प्रत्येक स्मारक/स्थल/अवशेष के नाम के आगे उल्लेख किया गया है, के द्वारा केन्द्रीय संरक्षित स्मारक घोषित कर पृष्टि की गई है। इन नियमों कि प्रावधान निम्नप्रकार है:-

Sec 2(i): **"Protected Area"** means any archaeological site and remains which is declared to be of national importance by or under this Act.

Sec 2(j): **"Protected Monument"** means an ancient monument which is declared to be of national importance by or under this Act.

03. इस संबंध में यह सूच्य है कि, प्राचीन स्मारक, ऐतिहासिक / पुरातत्त्वीय स्थल एवं अवशेष की संरक्षण हेतु पहले प्राचीन स्मारक पिरक्षिण अधिनियम 1904 में दिए गए प्रावधानों के अनुसार किया जा रहा था। वर्ष 1958 में (i) प्राचीन एवं ऐतिहासिक स्मारकों एवं पुरातात्त्विक स्थलों तथा अवशेषों जो राष्ट्रीय महत्व के है के पिरक्षिण हेतु, (ii) पुरातात्त्विक उत्खनन के विनियमन हेतु तथा (iii) मूर्तियां, नक्काशी एवं इस प्रकार के अन्य तरह की वस्तुओं की सुरक्षा के लिए, उपरोक्त अधिनियम को निरसन करते हुए, प्राचीन स्मारक एवं पुरातात्त्विक स्थल तथा अवशेष अधिनियम 1958 एवं विनियम 1959 लागू किया गया है। इस अधिनियम के धारा 2(i), 2(j), 19 एवं विनियम 10, 31, 32, 33 तथा 38 के अनुसार प्राचीन स्मारक के संरक्षित क्षेत्र, संरक्षित स्मारक, संरक्षित क्षेत्र में संपत्ति के अधिकारों पर प्रतिबंध, संरक्षित क्षेत्र में निर्माण एवं अन्य कार्य के लिए अनुमित हेतु नियम, प्रतिबंधित एवं विनियमित क्षेत्रों की घोषणा, प्रतिबंधित एवं विनियमित क्षेत्रों घोषणा का असर एवं प्रतिबंधित तथा विनियमित क्षेत्रों से निर्माण हटाने के प्रावधान, का स्पष्ट उल्लेख किया गया है। इन नियमों के प्रावधान निम्नप्रकार है। इसके पश्चात सन 1992 में, केन्द्रीय सरकार के द्वारा, अधिसूचना एस.ओ—1764 दिनांक 16.06.1992 के माध्यम से प्रतिबंधित क्षेत्र एवं विनियमित क्षेत्र की सीमा (केन्द्रीय संरक्षित स्मारक / स्थल / अवशेष अथवा संरक्षित क्षेत्रों के चारदिवारी से शुरू होकर सभी ओर से 100 मीटर एवं इसके बाद 200 मीटर तक के क्षेत्र), घोषित किया गया है। अधिसूचना की एक प्रति आपके सुलभ संदर्भ हेतु, इस पत्र के साथ संलग्न है।

#### Sec 19: Restrictions on enjoyment of property rights in protected areas

(1) No person, including the owner or occupier of a protected area, shall construct any building within the protected area or carry on any moning, quarrying, excavating, blasting or any operation of a like nature in such area, or utilize such area or any part thereof in any other manner without the permission of the Central Governemt.

Provided that nothing in this sub-section shall be deemed to prohibit the use of any such area or part thereof for purposes of cultivation if such cultivation does not involve the digging of not more than one foot of soil from the surface.

(2) The Central Government may, by order, direct that any building constructed by any person within a protected area in contravention of the provisions of sub-section (1) shall be removed with a specified period and, if the person refuses or fails to comply with the order, the Collector may cause the building to be removed and the person shall be liable to pay the cost of such removal.

# Rule 10: Construction and Other operations in protected area (Permission required for construction etc.)

- (1) No person shall undertake any construction or mining operation within a protected area except under and in accordance with a permission granted in this behalf by the Central Government.
- (2) Every application for permission under rub-rule shall be made to the Central Government in prescribed form at least three months before the date of commencement of the construction or operation.

## Rule 31: Notice of intention to declare a prohibited or regulated area.

- (1) Before declaring an area near or adjoining a protected monument to be a prohibited area or a regulated area for purposes of mining operation or construction or both, the Central Government shall, by notification in the Official Gazette, give one month's notice of its intention to do so, and a copy of such noitification shall be affixed in a conspicuous place near the area.
- (2) Every such noitification shall specify the limits of the area which is to be so declared and shall also call for objection, in any, from interest persons.

### Rule 32: Declaration of prohibited or regulated area

After the expiry of one month from the date of the noitification under rule 31 and after considering the objections, if any, received within the said period, the Central Government may declare, by notification in the Official Gazette, the area specified in the notification under rule 31, or any part of such area, to be a prohibited area, or, as the case, may be, a regulated area for purposes of mining operation or construction or both.

#### Rule 33: Effect of declaration or prohibited or regulated area

No person other than an archaeological officer shall undertake any mining operation or any construction –

- (a) In a prohibited area, or
- (b) In a regulated area except under and in accordance with the terms and conditions of a licence granted by the Director General.

# Rule 38: Removal of unauthorised buildings

- (1) The Central Government may, by order, direct the owner or occupier of an authorised building in a prohibited area or in a regulated area or of a building or part thereof, which has been constructed in contravention of any of the conditions of a licence granted under rule 35 to remove such building or part thereof within a period specified in that order.
- (2) If the owner or occupier refuses or fails to comply with an order made under sub-rule (1), the Central Government may direct the District Magistrate to cause the building or part thereof to be removed and the owner or occupier shall be liable to pay the cost of such removal.

03. यह सूच्य है कि केन्द्रीय सरकार द्वारा उठाए गए कुछ कार्यवाही की मान्यता के लिए कुछ प्रावधान बनाने हेतु प्राचीन स्मारक एवं पुरातात्त्विक स्थल तथा अवशेष (संशोधन एवं विधिमान्यकरण) अधिनियम 2010 भारत के राजपत्र के माध्यम से प्रकाशित किया गया है। इस प्रकार से संशोधित अधिनियम के धारा 19 के तहत संरक्षित क्षेत्रों में स्थित सम्पत्ति अधिकार उपभोग करने हेतु प्रतिबंधन एवं प्राचीन स्मारक पुरातत्त्वीय स्थल एवं अवशेष विनियम 1959 के नियम 10 के अनुसार संरक्षित क्षेत्र में निर्माण आदि हेतु अनुमित के संबंध में प्रावधानों का उल्लेख किया गया है। इसके अलावा, धाराएँ 20(ए) एवं 20(बी) के अनुसार केन्द्रीय संरक्षित स्मारक /स्थल/अवशेष अथवा संरक्षित क्षेत्रों के चारदिवारी से शुरू होकर सभी ओर से 100 मीटर एवं इसके बाद 200 मीटर तक के क्षेत्र को यथाकम प्रतिषिद्ध क्षेत्र (Prohibited area) एवं विनियमित क्षेत्र (Regulated area) के रूप में विनिर्दिष्ट करने के पश्चात धाराएँ 20(सी) एवं 20(डी) के अनुसार इन क्षेत्रों में निर्माण /खनन आदि के लिए अनुमित प्राप्त करने हेतु आवेदन तथा सक्षम प्राधिकारी का प्रावधान किया गया है। इसके अलावा यह भी सूच्य है कि उक्त अधिनियम के धाराएँ 30, 30ए एवं 30बी के अनुसार नियमों के उल्लंधन की सजा का भी प्रावधान उल्लंख है। उपर्युक्त नियमों का प्रावधान निम्नप्रकार है। इस संबंध यह उल्लेख करना प्रासंगिक होगा कि छत्तीसगढ़ राज्य के लिए, संचालक /निदेशक, संस्कृति एवं पुरातत्त्व संचालनालय, छत्तीसगढ़ सरकार, एम0जी0एम संग्रहालय, सिविल लाईन, रायपुर—492001, छत्तीसगढ़ को सक्षम प्राधिकारी के रूप से नियुक्त किया गया है। यह भी सूच्य है कि सक्षम प्राधिकारी के पास आवेदन हेतु निर्धारित प्रपत्र के अनुसार संगत दस्तावेजों के साथ हि आवेदन करना है। निर्धारित प्रपत्र की प्रतिलिपि इस पत्र के साथ संलग्न है।

# Sec 20A: Declaration of prohibited area and carrying out public work or other works in prohibited area

Every area, beginning at the limit of the protected area or the protected monument, as the case may be, and extending to a distance of one hundred meters in all directions shall be the prohibited area in respect of such protected area or protected monument:

Provided that the Central Government may, on the recommendation of the Authority, by notification in the Official Gazette, specify an area more than one hundred meters to be the prohibited area having regard to the classification of any protected monument or protected area, as the case may be, under section 4A,

- (2) Save as otherwise provided in section 20(C), no person, other than an archaeological officer, shall carry out any construction in any prohibited area.
- (3) In a case where the Central Government or the Director General, as the case may be, is satisfied that –
- (a) It is necessary or expedient for carrying out such public work or any protect essential to the public; or
- (b) Such other work or project, in its opinion, shall not have any substantial adverse impact on the preservation, safety, security of, or, access to, the monument or its immediate surrounding,

It or he may, notwithstanding anything contained in sub-section (2), in exceptional cases and having regard to the public interest, by order and for reasons to be recorded in writing, permit, such public work or protect essential to the public or other constructions, to be carried out in a prohibited area:

Provided that any area near any protected monument or its adjoining area declared, during the period beginning on or after the 16th day of June 1992 but ending before the date on which the Ancient Monuments and Archaeological Sites and Remains (Amendment and Validation) Bill, 2010, receives the assent of the President, as a prohibited area in respect of such protected monument, shall be deemed to be the prohibited area declared in respect of that protected monument in accordance with the provisions of this Act and any permission or licence granted by the Central Government or the Director General, as the case may be, for the construction within the prohibited area on the basis of the recommendation of the Expert Advisory Committee, shall be deemed to have been validly granted in accordance with the provisions of this Act, as if this section had been in force at all material times:

Provided further that nothing contained in the first proviso shall apply to any permission granted, subsequent to the completion of construction or re-construction of any building or structure in any prohibited area in pursuance of the notification of the Government of India in the Department of Culture (Archaeological Survey of India) number S.O.1764 dated the  $16^{\rm th}$  June 1992 issued under rule 34 of the Ancient Monuments and Archaeological Sites and Remains Rules 1959, or, without having obtained the remommendations of the Committee constituted in pursuance of the order of the Government of India number 24/22/1006-M dated  $20^{\rm th}$  July 2006 (subsequently referred to as the Expert Advisory Committee in order dated  $27^{\rm th}$  August, 2008 and the  $5^{\rm th}$  May 2009).

(4) No permission, referred to in sub-section (3), including carrying out any public work or project essential to the public or other constructions, shall be granted in any prohibited area on and after the date on which the Ancient Monuments and Archaeological Sites and Remains (Amendment and Validation) Bill 2010 receives the assent of the President.

### Sec 20B: Declaration of regulated area in respect of every protected monument

Every area, beginning at the limit of the prohibited area in respect of every ancient monument and archaeological site and remains, declared as of national importance under section 3 and 4 and extending to a distance of two hundred meters in all directions shall be regulated area in respect of every ancient monument and archaeological site and remains:

Provided that the Central Government may, by notification in the Official Gazette, specify an area more than twoo hundred meters to be the regulated area having regard to the classification of any protected monument or protected area, as the case may be, under section 4A:

Provided further that any area near any protected monument or its adjoining area declaed, during the period beginning on or after the 16th day of June 1992 but ending before the date on which the Ancient Monuments and Archaeological Sites and Remains (Amendment and Validation) Bill, 2010 receives the assent of the President, as a regulated area in respect of such protected monument, shall be deemed to be the regulated area declared in respect of that protected monument in accordance with the provisions of this Act and any permission or licence granted for construction in such regulated area shall be deemed to have been validly granted in accordance with the provisions of this Act, as if this section had been in force at all material times.

# Sec 20C: <u>Application for repair or renovation in prohibited area or construction</u> or reconstruction or repair or renovation in regulated area

- (1) Any person, who owns any building or structure, which existed in a prohibited area before the 16<sup>th</sup> day of June 1992, or, which had been subsequently constructed with the approval of the Director General and desires to carry out any repair or renovation of such building or structure, may make an application to the competent authority for carrying out such repair or renovation, as the case may be.
- (2) Any person, who owns or possesses any building or structure or land in any regulated area, and desires to carry out any construction or re-construction or repair or renovation of such building or structure on such land, as the case may be, may make an application to the competent authority for carrying out construction or re-construction or repair or renovation, as the case may be.

### Sec 20D: Grant of permission by Competent Authority within regulated area

- (1) Every application for grant of permission under section 20C of this Act shall be made to the competent authority in such manner as may be prescribed.
- (2) The competent authority shall, within fifteen days of the receipt of the application, forward the same to the Authority to consider and intimate impact of such construction (including the impact of large-scale development project, public project and protect essential to the public) having regard to the heritage bye-laws relating to concerned protected monument or protected area, as the case may be:

Provided that the Central Government may prescribe the category of applications in respect of which the permission may be granted under this sub-section and the application which shall be referred to the Authority for its recommendations.

(3) The Authority shall, within two months from the date of receipt of application under sub-section (2), intimate to the competent authority impact of such construction (including the impact of large-scale development project, public project and project essential to the public).

- (4) The competent authority sha,, within one month of the receipt of intimation from the Authority under sub-section (3), either grant permission or refuse the same as so recommended by the Authority.
  - (5) The recommendations of the Authority shall be final.
- (6) In case the competent authority refuses to grant permission under this section, it shall, by order in writing, after giving an opportunity to the concerned person, intimate such refusal within three months from the date of receipt of the application to the applicant, the Central Government and the Authority.
- (7) If the competent authority, after grant of the permission under subsection (4) and during the carrying out of the repair or renovation worl or re-construction of building or construction referred to in that sub-section, is of the opinion (on the basis of material in his possession or otherwise) that such repair or renovation work or reconstruction of building or construction is likely to have an adverse impact on the preservation, safety, security or access to the monument considerably, if may refer the same to the Authority for its recommendations and if so recommended, withdraw the permission granted under sub-section (4) if so required:

Provided that the competent authority may, in exceptional cases, with the approval of the Authority grant permission to the applicant referred to in sub-section (2) of section 20C until the heritate bye-laws have been prepared under sub-section (1) of section 20E and published under sub-section (7) of that section.

(8) The Central Government, or the Director General, as the case may be, shall exhibit, on their website, all the permissions granted or refused under this Act.

#### Sec 30: Amendment of Section 30

#### (1) Whoever -

- (i) Destroys, removes, inquires, alters, defaces, imperils, or misuse a protected monument, or
- (ii) Being the owner or occupier of a protected monument, contravenes an order made under sub-section (1) of section 9 or under sub-section (1) of section 10, or
- (iii) Removes from a protected monument any sculpture, carving, image, bas-relief, inscription, or other like object, or
- (iv) Does any act in contravention of sub-section (1) of section 19, shall be punishable with imprisonment which may extend to Two Years with Fine which may extend to One Lakh Rupees, or with Both.
- (2) Any person who moves any antiquity in contravention of a notification issued under sub-section (1) of section 25 shall be punishable with imprisonment which may extend to Two Years or with Fine which may extend to One Lakh Rupees or with Both; and the court conviction a person of any such contravention may by order direct such person to restore the antiquity to the place from which it was moved.

#### Sec 30A: Punishment for construction etc in prohibited area

Whoever raises, on and after the date on which the Ancient Monuments and Archaeological Sites and Remains (Amendment and Validation) Bill, 2010, receives the assent of the President, any construction in the prohibited area, shall be punishable with imprisonment not exceeding Two Years or with Fine which may extend to One Lakh Rupees or with Both.

#### Sec 30B: Punishment for construction etc in regulated area

Whoever raises, on and after the date on which the Ancient Monuments and Archaeological Sites and Remains (Amendment and Validation) Bill, 2010, receives the assent of the President, any construction in the regulated area without the previous permission of the competent authority or in contravention of the permission granted by the competent authority, shall be punishable with imprisonment not exceeding Two Years or with Fine which may extend to One Lakh Rupees or with Both.

- 04. किन्तु यह देखा जा रहा है कि इस तरह के एक पुराने अधिनियम एवं नियम होने के बावजूद, इर्नेके प्रावधानों को ध्यान में नै लेकर संबंधित नगर निगम, नगर पालिका परिषद, नगर पंचायत के कार्यालयों के द्वारा, केन्द्रीय संरक्षित स्मारकों/स्थलों/अवशेषों के उपर्युक्त निर्धारित सीमा के भीतर स्थित भूमि पर नवनिर्माण, पुननिर्माण, नवीनीकरण, मरम्मत आदि के लिए, प्राधिकृत सक्षम प्राधिकारी या भारतीय पुरातत्त्व सर्वेक्षण को बिना सूचित किए, अनुमति जारी की जा रही है।
- 05. अतः यह अनुरोध है कि केन्द्रीय संरक्षित स्मारक/स्थल/अवशेष के संरक्षित/प्रतिबंधित/विनियमित क्षेत्रों में नविनर्माण, पुनिनर्माण, नवीनीकरण, मरम्मत आदि के लिए, उपर्युक्त नियमों का प्रतिपालन सुनिष्टिचत करने का कष्ट करें एवं संबंधित व्यक्ति जो अनुमित हेतु आपके पास आवेदन प्रस्तुत किए है, को इस संबंध में आवश्यक सूचना देने का कष्ट करें तािक भविष्य में किसी भी प्रकार की कानूनी कार्यवाही से बचा जा सके। यह भी अनुरोध है कि, भारतीय संविधान के अनुच्छेद 49 तथा 51ए(एफ) के प्रावधानों जिसकी प्रतिलिपियां भी इस पत्र के साथ संलग्न है, को ध्यान में रखते हुए केन्द्रीय संरक्षित स्मारक/स्थल/अवशेष के संरक्षित/प्रतिबंधित/विनियमित क्षेत्रों से अतिक्रमण एवं अवैध निर्माण/खनन को हटाने के लिए इस कार्यालय के द्वारा की जा रही कार्यवाही में सहायता प्रदान करने का कष्ट करें तथा इस प्रकार के अवैध निर्माण/खनन होने न दें।
- 06. यह सूच्य है कि उपर्युक्त विषय के संबंध में विभिन्न अधिनियमों और विनियमों के प्रावधानों को जानने के लिए आप भारतीय पुरातत्त्व सर्वेक्षण महानिदेशालय अथवा इस कार्यालय के वेब साईट यथाकम asi.nic.in or asiraipurcircle.in का उपयोग कर सकते हैं। यह भी सूचित किया जाता है कि अगर कोई भी केन्द्रीय संरक्षित स्मारक आपके क्षेत्राधिकार के अंतर्गत नहीं है तो इस पत्र की मूलप्रति / प्रतिलिपि, इस कार्यालय को सूचना देते हुए, संबंधित नगर पालिका या नगर पंचायत को अग्रेषित करने का भी कष्ट करें।

# Notifications under the various Provisions of the Ancient Monuments and Archaeological Sites and Remains Act, 1952 and Rules, 1959

The Central Government gave one month's notice of its intention to declare areas upto 100 meters from the protected limits, and further beyond it upto 200 meters near or adjoining protected monuments to be prohibited and regulated areas respectively for purposes of both mining operation and construction.

S.O. 1764, dated 16th June, 1992. Whereas by the notification of the Government of India in the Department of Culture, Archaeological Survey of India No. S.O. 1447 dated 15th May, 1991, published in the Gazette of India, Part II, Sections 3, sub-section (ii) dated 25th may, 1991, the Central Government gave one month's notice of its intention to declare areas upto 100 meters from the protected limits, and further beyond it upto 200 meters near or adjoining protected monuments to be prohibited and regulated areas respectively for purposes of both mining operation and construction:

And whereas the said Gazette was made available to the public on 5th June, 1991;

And whereas objections to the making of such declaration received from the person interested in the said areas have been considered by the Central Government.

Now, therefore, in exercise of the powers conferred by rule 32 of the Ancient Monuments and Archaeological Sites and Remains Rules, 1959, the Central Government hereby declares the said areas to be prohibited and regulated areas. This shall be in addition to and not in any way prejudice the similar declarations already made in respect of monuments at Fatehpur Sikri; Mahabalipuram; Golconda Fort, Hyderabad (Andhra Pradesh); Thousand Pillared Temple, Hanamkonda, District Warangal (Andhra Pradesh); Sher Shah's Tomb, Sasaram (Bihar); Rock Edict of Ashoka, Kopbal, District Raichur (Karnataka); Fort Wall, Bijapur (Karnataka); Gomateswara Statue at Sravanbelgola, District Hassan (Karnataka); Elephanta Caves, Gharapur, District Kolaba (Maharashtra).

#### THE CONSTITUTION OF INDIA

(Part IV.—Directive Principles of State Policy.— Arts. 48A—51.)

Protection and improvement of environment and safeguarding of forests and wild life <sup>1</sup>[48A. The State shall endeavour to protect and improve the environment and to safeguard the forests and wild life of the country.]

Protection of monuments and places and objects of national importance. 49. It shall be the obligation of the State to protect every monument or place or object of artistic or historic interest, <sup>2</sup>[declared by or under law made by Parliament] to be of national importance, from spoliation, disfigurement, destruction, removal, disposal or export, as the case may be.

Separation of judiciary from executive.

**50.** The State shall take steps to separate the judiciary from the executive in the public services of the State.

Promotion of international peace and security.

- 51. The State shall endeavour to—
  - (a) promote international peace and security;
- (b) maintain just and honourable relations between nations;
- (c) foster respect for international law and treaty obligations in the dealings of organized peoples with one another; and
- (*d*) encourage settlement of international disputes by arbitration.

#### **FUNDAMENTAL DUTIES**

51A. It shall be the duty of every citizen of India—

(a) to abide by the Constitution and respect its ideals and institutions, the National Flag and the National Anthem;

- (b) to cherish and follow the noble ideals which inspired our national struggle for freedom;
- (c) to uphold and protect the sovereignty, unity and integrity of India;
- (d) to defend the country and render national service when called upon to do so;
- (e) to promote harmony and the spirit of common brotherhood amongst all the people of India transcending religious, linguistic and regional or sectional diversities; to renounce practices derogatory to the dignity of women;
- (f) to value and preserve the rich heritage of our composite culture;
- (g) to protect and improve the natural environment including forests, lakes, rivers and wild life, and to have compassion for living creatures;
- (h) to develop the scientific temper, humanism and the spirit of inquiry and reform;
- (i) to safeguard public property and to abjure violence;
- (j) to strive towards excellence in all spheres of individual and collective activity so that the nation constantly rises to higher levels of endeavour and achievement;
- \*[(k) who is a parent or guardian to provide opportunities for education to his child or, as the case may be, ward between the age of six and fourteen years.]
